Effective January 1, 2002, OSHA changed the record keeping guidelines. The municipality now counts the number of days lost from the day after the injury until the employee returns to work. - **WHEREAS**, Section 4 of IC 36-8-2 provides that a unit of local government may regulate conduct, or use or possession of property that might endanger the public health, safety or welfare;
- WHEREAS, Section 8 of IC 36-8-2 provides that a unit of local government may regulate the introduction of any substance, or odor into the air, or any generation of sound;
- WHEREAS, Section 9 of IC 36-8-2 provides that a unit of local government may regulate public gatherings;
- WHEREAS, Section 7 of IC 36-9-2 provides that a unit of local government may regulate the use of public ways;
- WHEREAS, Section 17(h) of IC 10-14-3 provides that each local or interjurisdictional agency shall prepare and keep current a local or interjurisdictional disaster emergency plan for its area;
- WHEREAS, Highland Indiana recognizes the threat that natural hazards pose to people and property;
- **WHEREAS**, Undertaking hazard mitigation actions before disasters occur will reduce the potential for harm to people and property and save taxpayer dollars;
- WHEREAS, An adopted Multi-Hazard Mitigation Plan is required as a condition of future grant funding for mitigation projects;
- WHEREAS, The Lake County Emergency Management Agency and Department of Homeland Security did assemble a special update planning committee with a representative knowledgeable in local hazards from all the participating local governments in Lake County to work on the update of the existing Multi-Hazard Mitigation Plan and development of a Updated and Revised Multi-Hazard Mitigation Plan.
- **NOW, THEREFORE BE IT RESOLVED** by the Town Council of Highland, Lake County, Indiana, as follows:
- **Section 1.** That the Highland Town Council hereby adopts the Lake County Multi-Hazard Mitigation Plan as an official plan for the Town, which is incorporated as an exhibit affixed to this resolution;
- **Section 2.** That that the Lake County Department of Homeland Security/Emergency Management Agency will submit on behalf of the participating municipalities the adopted Multi-Hazard Mitigation Plan to the Indiana Department of Homeland Security and the Federal Emergency Management Agency for final review and approval.

Section 3. That the proper officials, agents and employees of the Town are hereby authorized and directed to take such further action as they may deem necessary or appropriate to perform all obligations and commitments of the Town in accordance with the provisions of the Agreement, provided it is approved by the Indiana Department of Homeland Security and the Federal Emergency Management Agency;

Section 4. That the Fire Chief or the Clerk-Treasurer shall transmit a fully executed resolution to the proper officer of the Lake County Department of Homeland Security/Emergency Management Agency to evidence its adoption by the Town of Highland.

Whereas, Title 36, Article 1 Chapter 4 of the Indiana Code confers certain general corporate powers on the several units of government in Indiana;

Whereas, IC 36-1-4-17, and IC 34-13-3-16, authorize in pertinent part that a governing body of a political subdivision may compromise and settle a claim brought against the political subdivision or its employees;

Whereas, The Town Council is reliably informed by the Town Attorney and the Police Chief regarding an incident occurring under Case #19-6740, in which storage fees incurred against Mary Kay Shank;

Whereas, It is recommended by the Police Chief and the Town Attorney that a settlement payment in the amount of three hundred fifty dollars (\$350.00) be paid to indemnify Mary Kay Shank for the storage fees;

Whereas, It is in the interest of operational and administrative economy as well as in the best interest of the municipality to render a settlement for the storage fees with an associated release foreclosing further action; and

Whereas, The Town Council now desires to approve and authorize the settlement and release agreement, and indemnify Mary Kay Shank for the storage fees,

Now, Therefore Be It Ordered by the Town Council of the Town of Highland, Lake County, Indiana, acting as the Works Board of Municipality as well as the governing body of the municipality as follows:

Section 1. That the Works Board hereby finds and determines that the terms and provisions of the release and indemnity agreement to be reasonable and approved in each and every respect (Agreement affixed as an exhibit to this order);

Section 2. That the Works Board hereby finds and determines that the identified sum for payment to Mary Kay Shank as indemnitor, in the amount of three hundred fifty dollars (\$350.00) to be reasonable and acceptable for the purposes of settlement;

Section 3. That the Works Board Order still further finds and determines it hereby to be in the interest of operational and administrative economy as well as in the best interest of the municipality to approve a settlement for the storage fees with an associated release foreclosing further action;

Section 4. That the proper officers are now authorized and approved to execute the indemnity agreement, that the Clerk-Treasurer must identify proper resources to support the purposes of this order and be authorized to make payment according to its terms;

The Chief noted that the department responded to and assisted with incidents in neighboring communities. He noted that the Fire Department provided an honor guard for Assistant Fire Chief Mike Pipta's mom's funeral.

• **Council President Steve Wagner:** Town Executive • Chair of the Board of Police Pension Trustees • Advisory Board of Zoning Appeals Liaison.

The Council President acknowledged the Building Commissioner who offered a survey of matters pending before the Advisory Board of Zoning Appeals.

The Town Council President also congratulated the Parks and Recreation Superintendent on his attainment of the Ivan H. Brinegar Municipal Management Award.

Comments from Visitors or Residents:

- 1. Tom Black, 3515 Garfield Street, Highland, asked whether the Public Works Facility was being moved to be co-located with the proposed senior housing facility to be sited on Cline avenue next to Strack and Van Til's Supermarket. It was noted that the public works facility was not going to be moved to be sited with the senior facility.
- 2. Larry Kondrat, 8115 4th Place East, Highland, noted that Russell Development did not attend a recent hearing before the Plan Commission. Mr. Kondrat inquired whether the matter would be rescheduled. It was noted that the developer was scheduled to be at the meeting of Wednesday September 18, 2019.
 - Mr. Kondrat further inquired whether the Town Council would be more specific about the subject matter of the executive session at 7:30 p.m., noting that the notice indicated that the subject was to discuss the strategy regarding the purchase or sale of property. No further specificity beyond the notice was offered.

Mr. Kondrat asked about the status of the school town's rehabilitation of its football field with an artificial turf surface. The issue was still being reviewed regarding the impact on drainage.

- 3. Richard Underkofler, 9315 Idlewild Drive, Highland, reported that the Highland Community Foundation still had 39 trees available to be given to residents who wished to have one, that were provided under the auspices of a grant that started with 100 trees.
- 4. Elijah Aurand, 9315 Farmer Drive, Highland, sought clarification regarding whether the public could attend and observe an executive session. He was advised that the meeting for special reasons did not permit public review.

Mr. Aurand further inquired about the purposes of creating a list of approved and prohibited trees. He was advised about it being an element of the Urban Tree Management Plan that was adopted earlier in the year by the Town Council.

Mr. Aurand suggested that perhaps the Town Council inquire of the developer who is proposing senior housing at the site near Cline Avenue to see if Highland residents might be granted a reduction or discount.

Payment of Accounts Payable Vouchers. There being no further comments from the public, Councilor Zemen moved to allow the vendors accounts payable vouchers as filed on the pending accounts payable docket, covering the period August 27, 2019 through September 09, 2019 as well as ratifying the payroll dockets for the payday of August 16. 2019. Councilor Vassar seconded. Upon a roll call vote, there were five affirmatives and no negatives. The motion passed. The accounts payable vouchers for the vendor docket were allowed, payments allowed in advance were ratified including the payroll docket, and for all remaining invoices, the Clerk-Treasurer was authorized to make payment.
