Silent Roll Call: Councilors Bernie Zemen, Mark Herak, Dan Vassar, and Konnie Kuiper were present. Councilor Steve Wagner was absent owing to a work commitment. The Clerk-Treasurer, Michael W. Griffin was present to memorialize the proceedings. A quorum was attained.

General Substance of Matters Discussed.

- 1. The Town Council reviewed and discussed the agenda of the imminent regular meeting.
- 2. The Town Council and the Public Works Director discussed the timetable for completion of the LaPorte Street gas line replacement project undertaken by Northern Indiana Public Service Company.

The study session ended at 6:58 O'clock p.m.

Regular meeting. The Twenty Eighth Town Council of the Town of Highland, Lake County, Indiana met in its regular session on Monday, October 08, 2018 at 7:00 O'clock P.M. in the regular place, the plenary meeting chambers of the Highland Municipal Building, 3333 Ridge Road, Highland, Indiana.

The Town Council President, Mark A. Herak presided. The Town Clerk-Treasurer, Michael W. Griffin, was present to memorialize the proceedings. The meeting was opened with the Councilor Dan Vassar reciting the Pledge of Allegiance to the Flag of the United States of America and offering a prayer.

Roll Call: Present on roll call were Councilors Bernie Zemen, Mark Herak, Dan Vassar, and Konnie Kuiper. Councilor Steve Wagner was absent owing to a work commitment. The Clerk-Treasurer, Michael W. Griffin was present to memorialize the proceedings. A quorum was attained.

Additional Officials Present: Jared Tauber, Attorney with Tauber Law Office; John M. Bach, Public Works Director; Peter Hojnicki, Metropolitan Police Chief; William R. Timmer, Jr., CFOD, Fire Chief; Kathy DeGuilio-Fox, Redevelopment Director; Alex M. Brown, CPRP, Parks and Recreation Superintendent; and Kenneth J. Mika, Building Commissioner, were present.

Also present Larry Kondrat, Board of Waterworks Directors; and Ed Dabrowski, IT Director (Contract) were also present.

Minutes of the Previous Meetings: The minutes of the regular meeting of 24 September 2018 were approved by general consent.

Special Orders:

1. Pre-Adoption Hearing of the Revised Proposed Fiscal Year 2019 Budget for the Town of Highland.

- (a) Verification of Publication: (Under latest law, no publication by unit in newspaper, just by Department of Local Government Finance online Gateway. The proposed components of budget must be submitted to the Gateway at least 10 days before the Preliminary Hearing. The revised proposed budget notice was filed with the Gateway on September 26, 2018) (See IC 6-1.1-17-3) It was noted that owing to the discovery of an under representation in two funds of the desired appropriations, it was determined to republish and conduct an new hearing on the revised proposed civil town budget.
- (b) Introduction of **Revised Proposed Ordinance No. 1684:** An Ordinance of Appropriations and Budget Levies and Rates for the 2019 Budget. Councilor Zemen introduced and filed Ordinance No. 1684 as revised. There was no further action.
- (c) **Public Hearing.** The Town Council President opened the public hearing. The following person offered the following inquiry.
 - 1. Larry Kondrat, 8115 4TH Place East, Highland, asked about the changes to the revised proposed budget and sought clarification regarding the meaning of the column in the notice described as "Budget Estimate" and "Maximum Estimated Funds to be Raised". With leave from the Town Council, the Clerk-Treasurer explained that the Redevelopment General Fund and the Cumulative Capital Development Fund were reduced in the first iteration of the notice by the estimated amount of circuit breaker loss. The current iteration corrects this. The Clerk-Treasurer also explained that the column styled as "Budget Estimate" represents the planned spending (appropriations) in the several funds, and the column styled as "Maximum Estimated Funds to be Raised", refers to the total property taxes sought for the specific fund.

There was no further inquiries or comments. The Town Council President closed the hearing.

Pursuant to IC 6-1.1-17 et seq., consideration of the proposed ordinance for adoption cannot take place sooner than ten (10) days following the pre-adoption hearing. Consideration for passage and adoption of the Proposed Ordinance will be at the regular meeting of the **Town Council**, **Monday**, **October 22**, **2018** at **7:00** p.m.

It was noted that Ten (10) or more taxpayers may object to a budget, a tax rate or tax levy by filing a petition with the Office of the Clerk-Treasurer not more than seven (7) days following these hearings. (Monday, October 15, 2018) The objection petition must identify the provisions of the budget, tax rate or tax levy to which taxpayers object. If a petition is filed, the Town Council shall adopt with the budget a finding concerning the objections in the petition and the testimony presented.

A reminder was further stated regarding the adoption hearing for the Sanitary District and Waterworks District. Pursuant to IC 6-1.1-17 et seq., consideration of the proposed ordinance for adoption cannot take place sooner than ten (10) days following the pre-adoption hearing. Consideration for passage and adoption of the Proposed Ordinances regarding the Sanitary District and Waterworks District Budgets will be at the regular meeting of the **Town Council, Monday, October 15, 2018 at 6:30 p.m.**

Whereas, The Mission Statement of the Highland Main Street Bureau is "...to restore,

A SPECIAL ENACTMENT TO LAWFULLY APPROVE CERTAIN DISABILITY RETIREMENT BENEFITS AS WELL AS DEFINING STATUS FOR POLICE OFFICER JOHN SWISHER, WHO HAS BEEN GRANTED A DISABILITY RETIREMENT FOR CATASTROPHIC INJURIES INCURRED IN THE LINE OF DUTY.

Whereas, The Town Council is the fiscal and legislative body of the Town of Highland, pursuant to IC 36-5 et sequitur;

Whereas, IC 36-1-3-2 confers upon all local units the powers that they need for the effective operation of government as to local affairs;

Whereas, IC 36-1-3-6 (b)(1) prescribes that any such exercise of power shall be authorized through enactment of an ordinance passed by the legislative body; and

WHEREAS, IC 36-1-4, sections 14 and 15 provide in pertinent parts for the establishment of a system of employment for any class of employee and for fixing the level of compensation of its officers and employees; and

Whereas, IC 36-5, Chapters 3 and 4 provide additional authority and guidelines for fixing the level of compensation of officers and employees in towns; and

WHEREAS, Police Officer First Class John Swisher, was on duty, responding to a call for service on December 10, 2016 at 12:57 a.m. heading northbound on the 9100 Block of Kennedy Avenue, Highland, when a southbound car operated by a legally intoxicated driver, crashed into him, head-on at a high rate of speed; and

Whereas, Police Officer First Class John Swisher, sustained catastrophic injuries, enduring several surgeries and medical interventions to repair many broken bones, experiencing protracted, extensive treatments and physical therapy from the date of the incident through the end of January 2018; and,

WHEREAS, Police Officer First Class John Swisher, has not been able to perform or return to any work including his duties as a Highland Police Officer, since the line of duty accident and attendance injuries from December 10, 2016 through the present date;

WHEREAS, The Town Council has been further advised that Police Officer First Class John Swisher applied for and received a determination from the State System Director regarding his catastrophic injuries sustained while on duty, his resulting permanent impairment, and his award of a line of duty disability pension, under IC 36-8-8 et seq.;

WHEREAS, The Town Council now desires to take the proper steps to authorize and approve lawful continued coverage under the group medical and dental insurance plans, for a limited period of time, provided under the provisions of the Compensation and Benefits Ordinance of the Town and the most recently adopted and effective wage and salary ordinance,

NOW, THEREFORE, BE IT HEREBY ENACTED by the Town Council of the Town of Highland, Lake County, Indiana, as follows:

- **Section 1.** That the Town Council makes the following findings and determinations, pursuant to its authority under IC 36-1-4-16 to ratify the actions of officers *post hoc*, as well as the authority described in the preamble to this enactment:
- (A) That the Highland Town Council finds and determines that Police Officer First Class John Swisher, was on duty, responding to a call for service on December 10, 2016 at 12:57 a.m. heading northbound on the 9100 Block of Kennedy Avenue, Highland, when a southbound car operated by a legally intoxicated driver, crashed into him, head-on at a high rate of speed;
- (B) That the Highland Town Council further finds and determines that Police Officer First Class John Swisher, sustained catastrophic injuries, enduring several surgeries and medical interventions to repair many broken bones, experiencing protracted, extensive treatments and physical therapy from the date of the incident through the end of January 2018;
- (C) That the Highland Town Council still further finds and determines that Police Officer First Class John Swisher, has not been able to perform or return to any work including his duties as a Highland Police Officer, since the line of duty accident and attendance injuries from December 10, 2016 through the present date;
- (D) That the Highland Town Council still further finds and determines that Police Officer First Class John Swisher has applied for and received a determination from the State System Director regarding his catastrophic injuries sustained while on duty, his resulting permanent impairment, and his award of a line of duty disability pension, under IC 36-8-8 generally and IC 36-8-8-13.3(f) in particular and has accepted the line of duty disability pension, subject to appeal for sufficiency;
- (E) That the Highland Town Council still further finds and determines that Police Officer First Class John Swisher has exhausted his sickness disability/workers compensation paid time off as provided by Section 5.01.01 and Section 6.02.02 of the Compensation and Benefits Ordinance commonly called the Employee Handbook, as well as that provided in and extended by Enactment No. 2018-32, which rendered continued compensation and benefits ending on September 22, and paid on September 28;
- **Section 2.** That based upon the forgoing, the Town Council does hereby authorize and approve the following:
- (A) That notwithstanding provisions of Section 6.07 (B), regarding the group health insurance plan for retired and separating public safety employees in the Compensation and Benefits Ordinance, Patrol Officer Swisher shall **not** be required to pay the employer's any share of the premium for the continuation of the group health or the group dental insurance benefit to the extent it's lawful;
- (B) That this enactment further directs that the extension and continuation of the group medical and dental insurance benefit provided by this enactment shall conclude and cease on **December 31, 2018**, but that this extension shall be revisited by the Town Council at the end that period, unless subsequent action by the Town Council ensues;
- **Section 3.** That the adoption of this enactment shall in no way be construed as a precedent for the subject department or any other department of the municipality, nor shall it be construed as creating an entitlement for any other workers in any other department, but rather the provisions in this enactment are specific, unique and particularly conferred for a public safety worker who has suffered and endured a unique, unusual, profound and "catastrophic physical personal injury" while in the line of duty;
- **Section 4.** That authority under this enactment shall be seen as complimentary to and not in derogation of the authority of the Clerk-Treasurer under IC 36-5-6-6, and that the payments authorized under this

enactment, are hereby deemed to be a type of expense identified under IC 36-5-4-12(b)(10) & (13).

Whereas, The price for the purchase exceeds \$15,000.00 and, pursuant to Section 3.05.040(E) as well as Section 3.05.050(A)(2) of the Highland Municipal Code requires the express approval of the purchasing agency; and

Whereas, The Town Council as the Works Board of the Municipality, pursuant to Section 3.05.030 (A)(2) of the Highland Municipal Code serves as the purchasing agency for the Metropolitan Police Department; and

Whereas, The Metropolitan Police Chief, pursuant to Section 3.05.050(D)(2) of the Highland Municipal Code, serves as the Purchasing Agent for the Metropolitan Police Department; and

Whereas, The Purchasing Agent, believes that this purchase qualifies as a special purchase to be made without soliciting bids or proposals because in this instance (1) the compatibility of equipment, accessories or replacement parts is a substantial consideration in this purchase and (2) only one source meets the department's reasonable requirements, which is the source recommended for this purchase;

Whereas, The Purchasing Agent, for the rationale stated herein, elects to purchase without resort to soliciting quotes or bids pursuant to Section 3.05.065(I) of the Highland Municipal Code;

Whereas, The purchase of the Glock weapons and accessories will be supported by appropriations in the Public Safety LIT Fund and the Federal Asset Forfeiture Fund;

Whereas, The Town Council now desires to approve and authorize the Police Chief to complete the purchase pursuant to the terms and stated herein,

Now, Therefore Be It Ordered by the Town Council of the Town of Highland, Lake County, Indiana, acting as the Works Board of Municipality:

Section 1. That the Works Board hereby authorizes and approves the purchase from Kielser's Police Supply, Inc, 2802 Sable Mill Road, Jeffersonville, IN for the purchase of Glock duty weapons as set forth in a quote, which is attached as an exhibit to and made a part of this order, in the estimated amount of \$32,189.37;

Whereas, First Group Engineering, Incorporated had been engaged to provide preliminary engineering services and right-of-way procurement services, which have been completed, and the project has been set for a February 2018 letting through the INDOT; and

Whereas, The Town needs to procure certain property as right of way for the project described herein;

Whereas, The Town of Highland as plaintiff initiated a cause of action with BKO Properties, LLC, to obtain certain property, owned by BKO and needed as rights of way for the project described herein;

Whereas, That an agreement has been presented that is a memorialization of the mediated settlement between the Town of Highland (plaintiff) and BKO Properties, LLC (defendant);

Whereas, The Town of Highland, through its Town Council acting as the Works Board, now desires to accept and approve the mediated settlement between the Town of Highland (plaintiff) and BKO Properties, LLC (defendant) as herein described,

Now Therefore Be it hereby ordered and resolved by the Town Council of the Town of Highland, Lake County, Indiana:

Section 1. That the Stipulation/Agreement made in consequence of a Mediation Conference held September 25, 2018, (incorporated by reference and made a part of this Order) between BKO Properties, LLC (defendant) and the Town of Highland (plaintiff) for certain property needed for right of way associated with the 45^{th} Avenue and 5^{th} Street Intersection Project is hereby approved, adopted, and ratified in each and every respect, with the parcel being further described as follows:

- WHEREAS, The duly approved and filed capital improvement plan, now in force, expressly includes support for "redevelopment efforts related to project of economic development and redevelopment in the several redevelopment and economic development areas which are in place or which may be established, including but not limited to the project known as Cardinal campus, and projects associated with the Kennedy Avenue Corridor located in the Downtown Allocation Area;"
- WHEREAS, The Town Council wishes to grant to the duly authorized purchasing agent of the Redevelopment Department, express authority to identify certain lawful expenses that may be posted to and paid by resources appropriated to the Economic Development Local Income Tax Fund;

NOW, THEREFORE, BE IT HEREBY ORDERED by the Highland Town Council, Lake County, Indiana as follows:

Section 1. That the duly authorized purchasing agent of the Redevelopment Department, is granted express authority to identify certain lawful expenses that may be posted to and paid by resources appropriated to the Economic Development Local Income Tax Fund, provided the following apply:

- (A) That such expenses would be lawful under and consistent with the purposes of the Redevelopment laws, if paid from other funds of the Redevelopment Department;
- (B) That such expenses are aligned with the most recently filed capital improvement plan in force as approved by the town council president;
- (C) That the municipal fiscal officer also indicates the expense conforms to the purposes and provisions of this order;

Section 2. That the authority granted by this order remains in effect for such period as there is an appropriation for redevelopment or economic development purposes in the Economic Development LIT Fund or until this order is repealed by action of the Town Council acting as the Works Board of the Town;

Be it So Ordered.

Councilor Vassar acknowledged the Parks and Recreation Superintendent, who offered a brief survey of programs in the Parks and Recreation Department.

Councilor Vassar thanked the Town Council President for his remarks at the dedication of the newly constructed Skate Park at Sheppard Park on September 29, 2019 at 1:00 p.m., particularly for their reference to the late Larry Vassar and his advocacy of such a facility.

Councilor Kuiper acknowledged the Fire Chief who reminded all of the annual Fire Department Open House on Saturday, October 2. The Fire Chief also reported that there were four members attending Fire School.

• **Councilor President Mark Herak:** Town Executive • Chair of the Board of Police Pension Trustees •Budget and Finance Chair • Liaison to the Board of Sanitary Commissioners • Town Board of Metropolitan Police Commissioners, Liaison.

The Town Council President acknowledged the Public Works Director who reported on the status of the annual leaf collection service and that the current service contract with the trash hauler will be expiring and that the Board of Sanitary Commissioners would be soon beginning the process of advertising for bids for a new agreement for solid waste services.

The Town Council President acknowledged the Police Chief who thanked the Town Council for its authorization and approval of the new weapons purchase.

Comments from Visitors or Residents:

- 1. Dr. Ted Radziwiecki, 3316 Ridge Road, Highland, further inquired about damages he asserts that his house sustained in consequence of contractors working on the construction of the Police Station. He sought further information on the status of his claim. (Dr. Radziwiecki also raised this during comments from the floor at the plenary meeting of the Town Council of September 24, 2018.) Dr. Radziwiecki further asserted that his possible difficulty with any statute of limitations might be attributable to the delay by Bliss McKnight in responding to his claim.
 - Mr. Tauber noted that he and the Town Attorney could not offer any further advise as the Town of Highland was their client.
- 2. Scott Houldieson, 8927 Parrish Avenue, Highland, inquired about the Town Council communicating with the Little Calumet River Basin Development Commission regarding silt build up in the river along the Highland line and its licensing of the Maya Energy Project.
- 3. Terry Steagall, 8577 Kleinman Road, Highland, expressed concerns over the Little Calumet River Basin Development Commission, and the sufficiency of the application of resources to certain assets in its charge particularly regarding its long term and short term plans for recreational improvements along the river in Highland.
 - Mr. Steagall also urged the Town Council to be more transparent regarding the proposed expansion of the Lincoln Community Center.
 - Mr. Steagall also suggested that the Town Council adopt a resolution regarding the expectations for the recently confirmed Associate Justice of the United States Supreme Court, Brent Kavanaugh as well as a separate resolution supporting the efforts of the United Steel Workers in the ongoing negotiations with steel makers.
- 4. Larry Kondrat, 8115 4th Place East, Highland, urged the Town Council to resist any suggestion to adopt any resolutions as suggested and instead to assist Dr. Radziwiecki with his issue regarding damage to his house.
