Enrolled Minutes of the Seventy Third Regular or Special Meeting For the Twenty-Eighth Highland Town Council Special Meeting Monday, October 15, 2018

The Special Meeting of the Highland Town Council was called to order at 6:36 p.m. at the Highland Municipal Building, 3333 Ridge Road, Highland, Indiana, in the plenary meeting chambers. The Town Council President, Mark A. Herak, presided and the Town Clerk-Treasurer, Michael W. Griffin, was present to memorialize the proceedings. The meeting was opened with the Town Council President leading the Pledge of Allegiance to the Flag of the United States of America.

Roll Call: Present on roll call were Councilors Bernie Zemen, Dan Vassar, Mark Herak, Steve Wagner, and Konnie Kuiper. The Clerk-Treasurer, Michael W. Griffin was present to memorialize the proceedings. A quorum was attained.

Officials Present: John M. Bach, Public Works Director; and Kathy DeGuilio-Fox were also present.

Additional Officials Present: Larry Kondrat, Board of Waterworks Directors; and Ed Dabrowski, IT Consultant (contract) were also present.

Special Orders:

- 1. Adoption Hearing of the Proposed Fiscal Year 2019 Budget of the Sanitary District, pursuant to IC 6-1.1-17-20. Under amendments to IC 6-1.1-17-20, the proper officers shall submit the proposed budget and property tax levies to the municipal fiscal body. The proposed budget and levy shall be submitted to the city or town fiscal body in the manner prescribed by the department of local government finance before September 2 of a year. The fiscal body of the city, town, or county (whichever applies) shall review each budget and proposed tax levy and adopt a final budget and tax levy for the taxing unit. The fiscal body may reduce or modify but not increase the proposed budget or tax levy. The final adoption vests with the Town Council. The Town Council will now take final action at this meeting of October 15, 2018.
- (a) **Verification of Publication:** (Under latest law, no publication by unit just by Department of Local Government Finance online Gateway. The proposed components of budget must be submitted to the Gateway at least 10 days before the Preliminary Hearing. The proposed budget notice was filed with the Gateway on September 13, 2018. Preadoption hearing was conducted at the Town Council meeting of Monday, September 24, 2018.) (See IC 6-1.1-17-3).
 - The Clerk-Treasurer reminded the Town Council of the law regarding publication and verified the publication of the proposed budget was submitted to the Gateway on September 13, 2018.
- (b) Memorandum regarding Taxpayer remonstrance petition. The Clerk-Treasurer prepared and filed a memorandum reporting that the deadline for filing a remonstrance petition was October 1, 2018. He further reported that no petition was filed on that date or any day since. The Clerk-Treasurer explained the reductions both to the 2018 budget as well as to the proposed 2019 budget that were determined by the Department Head.
- (c) **Public Hearing.** The Town Council President called the hearing to order. There were no comments. The hearing was closed.

BE IT HEREBY ORDAINED by the Town Council of the Town of Highland, Lake County, Indiana:

Such sums herein appropriated shall be held to include all expenditures authorized to be made during the year, unless otherwise expressly stipulated and provided by law;

Section 3. That in addition, for the purposes of raising revenue to meet the necessary expenses of the SANITARY DISTRICT of the TOWN OF HIGHLAND, the property tax levies and property tax rates as herein specified are included herein. Budget Form 4-B for all funds are incorporated by the signing of this form and must be completed and submitted in the manner prescribed by the Department of Local Government Finance;

Section 4. This ordinance shall be in full force and effect from and after its passage and approval by the Town Council of the Town of Highland, subject to its review and approval by the Department of Local Government Finance.
