 Department of Homeland Severe winter storm public assistance particularly represented on ClerkTreasurer's receipt number 23788 in the amount of \$36,577.37 as reimbursement in support of overtime costs for detailed personnel and certain equipment operating costs associated with a severe weather event from earlier in the year;

ORDINANCE No. 1571 of the TOWN of HIGHLAND, INDIANA

AN ORDINANCE TO MAKE SEVERAL TECHNICAL AMENDMENTS TO THE Current CODE OF ORDINANCES FOR THE TOWN OF HIGHLAND, STATE OF INDIANA, REVISING, RESTATING, ARRANGING AND COMPILING CERTAIN EXISTING GENERAL ORDINANCES OF THE TOWN OF HIGHLAND DEALING WITH SUBJECTS EMBRACED IN SUCH CODE OF ORDINANCES Into A SIMPLIFIED CODE, WITHOUT THE FORMAL RECITALS AND OTHER PARTS OF THE INDIVIDUAL ORDINANCES, MAKING SUCH CODE POSITIVE LAW OF THE MUNICIPALITY, ALL PURSUANT TO IC 36-1-5 ET SEQ.

- WHEREAS, Title 36, Article 1, Chapter 5 of the Indiana Code provides that the legislative body of a unit shall codify, revise, rearrange, or compile the ordinances of the unit into a complete, simplified code excluding formal parts of the ordinances;
- WHEREAS, The legislative body of this unit, the Town of Highland, is the Town Council, pursuant to IC 36-1-2-9(5) and IC 36-5-2-2;
- WHEREAS, The present general and permanent ordinances of the Town of Highland, formally codified in 2012, are in need of technical and substantive modifications not confined to any particular Title, Article or Chapter but nevertheless desirable to further improve and perfect the Code; and
- WHEREAS, The Town Council, is persuaded that it is necessary and desirable to adopt the several technical and substantive modifications not confined to any particular Title, Article or Chapter to further improve and perfect the Code,
- NOW, THEREFORE, BE IT HEREBY ORDAINED BY the Town Council of the Town of Highland, Lake County, Indiana, as follows:
 - **Section 1.** That such Code of Ordinances as adopted and in effect, now containing certain Titles, shall now have the following name changes to certain Titles:
 - (A) That Title 3 which now is entitled "Revenue and Finance", shall be amended to be entitled "Finance and Procurement."
 - (B) That Title 8 which is now entitled "Streets, Public Ways, and Sanitation (Solid Waste), shall be amended to be entitled, "Streets, Sidewalks and Public ways."
 - **Section 2.** That such Code of Ordinances now in effect shall consist of the following Titles:

Section 3. That Section 1.01.040 of the Highland Municipal Code be hereby repealed in its entirety and amended to include a successor section, to be styled Section 1.01.040, which shall read as follows:

1.01.040 Future codification.

Where necessary, the clerk-treasurer is authorized and instructed to communicate with the codifier to assign any ordinances of a general and permanent nature and pertaining to a subject or subjects contained in or covered by the code, that were passed and adopted from and after January 22, 2001, and up to and until the passage and adoption of a replacement or successor Code, the ordinance codified in this chapter, to the appropriate title and section in the code herein adopted, according to its numbering and citation protocols, within a timetable that the clerk-treasurer determines to be reasonable. [Ord. 1526 § 4, 2012].

- **Section 4**. That such Code of Ordinances as adopted and in effect, now containing certain Sections, shall now have the following name changes to certain sections as indicated:
 - (A) That Section 3.25.020 which now is entitled "Authorized financial instruments", shall be amended to be entitled "Authorized financial instruments for payments to the municipality."
 - (B) That Section 3.25.050 which now is entitled "Authorized financial instruments", shall be amended to be entitled "Authorized financial instruments for payments by the municipality."
- **Section 5**. That Section 3.25.040 of the Highland Municipal Code be hereby repealed in its entirety and amended to include a successor section, to be styled Section 3.25.040, which shall read as follows:

3.25.040 Added authority related to acceptance of bank or credit cards.

- (A) The municipality, its executive departments and its utilities may contract with any of the following:
 - (1) A bankcard or credit card vendor for acceptance of bankcards or credit cards.
- (2) A third-party online collection service for acceptance of bankcards or credit cards.
- (B) If there is a vendor transaction charge or discount fee, whether billed to the municipality, its executive departments and its utilities or directly charged to one of its accounts, the municipality, executive department or utility shall collect a fee equal to the transaction charge or discount fee imposed by the vendor;
- (B) (C) The municipality, its executive departments and its utilities may pay any applicable bank card or credit card service charge associated with the use of a bank card or credit card under this section. [Ord. $1394 \S 1$, 2008. Code $2000 \S 31.83$].
- **Section 6.** That Section 3.25.060 (C) of the Highland Municipal Code be hereby repealed in its entirety and amended to include a successor section, to be styled Section 3.25.060 (C), which shall read as follows:
 - (C) In making payments under subsection (B) of this section the clerk-treasurer shall maintain adequate documentation of the transactions so that they may be audited as provided by law, and the use of the instruments set forth in subsection (B) of this section shall be limited to the following purposes those payments authorized by IC 5-13-5 and those set forth in Chapter 3.10 of this Code.
- (1) Property or services purchased or leased from:

- (a) The United States government; or
- (b) An agency or a political subdivision of the United States government;
- (2) Insurance premiums;
- (3) Utility payments or utility connection charges;
- (4) Federal grant programs if:
 - (a) Advance funding is not prohibited; and
 - (b) The contracting party provides sufficient security for the amount advanced;
- (5) Grants of state funds authorized by statute;
- (6) Lease agreements or rental agreements;
- (7) Principal and interest payments on bonds;
- (8) Payroll;
- (9) State, federal, or county taxes; and
- (10) Lawful purposes that may be identified by the clerk-treasurer and authorized in writing and not inconsistent with this chapter. [Ord. $1394 \ \S \ 1$, 2008. Code $2000 \ \S \ 31.85$].
- **Section 7**. That **Section 8.05.050** of the Highland Municipal Code be hereby repealed in its entirety, in that it is duplicative and a redundant re-statement of Section 2.35.015 of the Highland Municipal Code;
- **Section 8.** That Section 2.35.015 (B) of the Highland Municipal Code be hereby repealed in its entirety and amended to include a successor section, to be styled Section 2.35.015 (B), which shall read as follows:
 - (B) "Exigent matter involving the operating conditions of local roads and streets" means incidents of snow, ice, or flooding that compromise the safety of public ways and arrests the ordinary flow of traffic, **and other extreme weather hazards** for which there has been effort expended for at least four consecutive hours **to remediate**;

Section 9. That this ordinance shall be effective from and after its passage and adoption as evidenced by the signature of the Town Council President and attested thereto by the Clerk-Treasurer, all pursuant to IC 36-5-2-10 and IC 36-5-2-10.2.

The Town Council President acknowledged the Redevelopment Director who reported on the status of Redevelopment initiatives, including the application to allow the Town Theater to have National Landmark Status.

The Town Council President also shared his condolences to the Adams Family on the recent passing of Dennis Adams, late of the 4^a Ward. He noted his significant impact even in his short time of service as an elected officer.

Comments from Visitors or Residents:

1. Dr. M.A. Rahmany, 10027 Westminster Lane, Munster, **owner of** 3081 Ridge Road and 2834 Highway Avenue, Highland, expressed his disappointment at the denial of his use variance petitions for those properties at the meeting of the Town Council of July 14, 2014. Dr. Rahmany also expressed disapproval that he was unable to have a meeting with the Town Council regarding his petitions and expressed disappointment with the Building Commissioner who he perceived contributed to his difficulty.

The Town Council President and the Town Attorney tried to dissuade his misimpression regarding the Building Commissioner, noting he was actually following the law and ordinances governing the matter. However, the Town Council President asked the Building Commissioner to meet with Dr. Rahmany in order to perhaps address some of his concerns.
