WHY A REFERENDUM?

When he talks about the need for the School Town's firstever referendum, School Board President Victor Garcia said residents aren't opposing the effort: They simply want to know why.

"Projections show – without new revenues – the school town will not have enough money by 2025 to operate as we do now," Asst. Superintendent Ryan Erdelac said.

The factors leading to an operating deficit, include:

- » Decline in enrollment that has led to an aggregate loss of \$2.4 million in state support.
- » The loss of an additional \$3.2 million because of the property tax circuit breaker.

There are three options to make up for the shortfall:

- » Cut academic programs and staff
- » Open Highland borders to out-of-district students to compensate for enrollment declines
- » Pass a referendum May 2.

"I believe our students deserve to continue with the quality education we are providing," Garcia said. "It has been shown that quality schools are also a big positive when it comes to maintaining and growing home values. What's good for our schools is good for our community."

WITH A REFERENDUM ...

- » Home values continue to rise.
- » Quality of life improves.
- » Educational program funding continues.
- » Teachers and staff remain on the job.
- » Safety for students, teachers and staff is maintained.

WITHOUT A REFERENDUM ...

- » Property values decline.
- » Young families choose other communities to invest in their family's home and future.
- » Deep budget cuts are on the table, including staff layoffs, closing a school building, cutting educational and finearts programming.
- Highland continues to lose quality teachers and staff to districts that offer better pay and benefits.
- » The School Town of Highland is unable to attract new teachers and staff.

WHY THE SCHOOL BOARD SUPPORTS THE REFERENDUM



As a land-locked community, Highland has limited options when it comes to adding housing units as a way to grow its student population. Few vacant lots remain. People who move here stay for all the town has to offer.

"We have a responsibility to the students whose parents have entrusted the education of their children to us and to the community that benefits from great schools to fight for them and for this referendum," School Board President Victor Garcia said. "We trust that residents will cast their ballot for the referendum on May 2."
