General Substance and Discussion

Move to Indiana Commissioners Sean Conley started with the first thing on the agenda is our guest Lisa from Move to Indiana.com We are excited to here about this program, we got a little bit of an oversight from Kathy last meeting. So, if you want to tell us a little more about it. Lisa, said absolutely. Did you want to me go over it, did you want the presentation? Comm. Huerter asked, tell why we should not do platinum? Lisa, said no there is not. As far as the different sponsorships, you can participate at any level. Robertson stated he would much rather see the Statues stay in Highland to Promise you and the other guy take everything else, he is more of theatre buff, so I think he is more interested in the projectors and stuff. Atty Reed, said why don't we ask him, if you don't want the statues, you just want all the equipment, we can divide it up. Comm. Leep agreed that would be nice, that's the art house, right? Comm. Robertson, said even if he wanted those just ask for \$50 bucks less, we still want to give the Statues to the Art House. Comm. Leep said the goal was just to get everything out of there. Comm. Conley said he can reach out to this Jackson Hall. Conversation was held that all were fine with no money as long as they take it away. The fact that they will come and move the stuff for \$150, they are doing a service by taking it out of there. Atty Reed said whatever the decision is at the Plenary meeting is that we. just this stuff gone. Comm. Leep said that is the one item that is listed under New Business.
